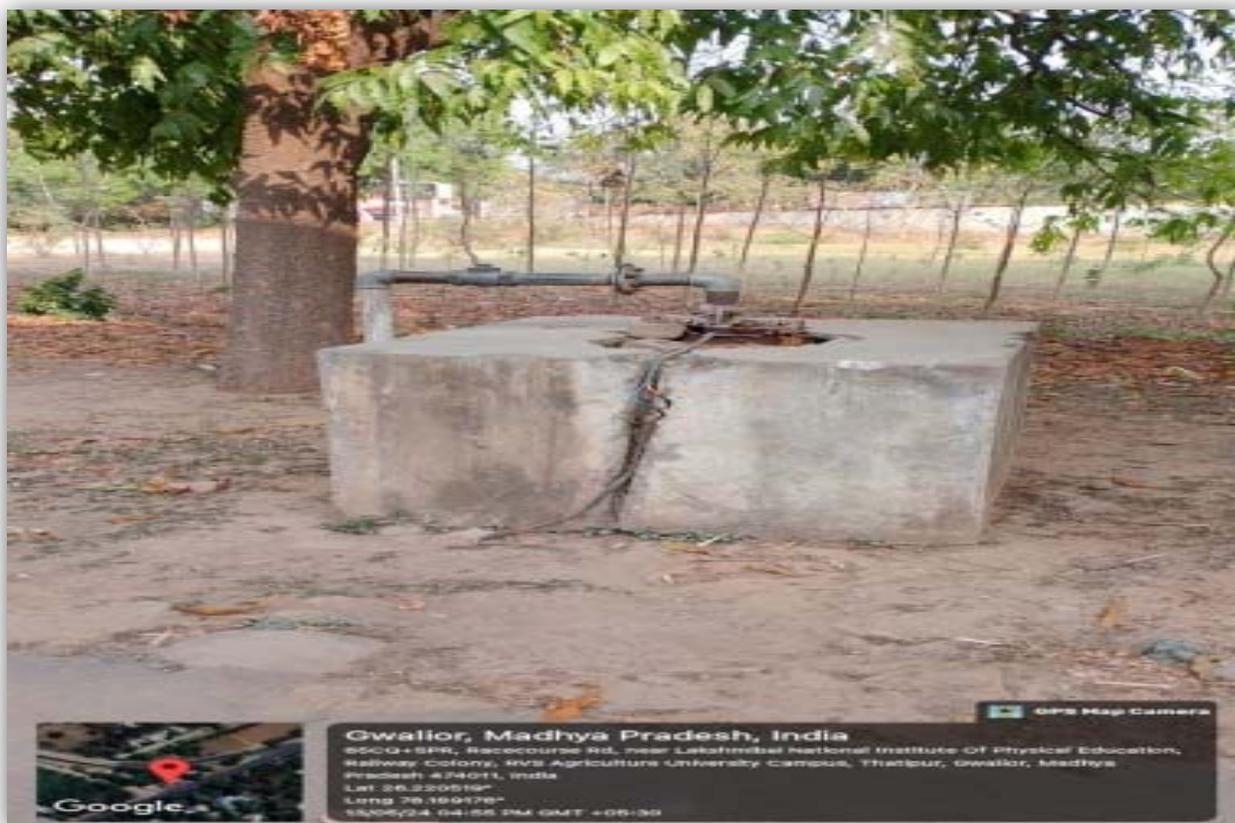


Drip Irrigation System
