**//ORDER//**

On the recommendation of the Assessment Committee, constituted under the provisions of section 5, 3 (B) (i) of the R.V.S.K.V.V., Statute 2014 and approval of Hon'ble Vice Chancellor the following Senior Technical Officers presently working in T-6 grade (Category III) in the 6<sup>th</sup> Pay Scale of Rs. 15600-39100+AGP 5400 are upgraded to the level of T-7/8 grade in the Pay Scale of Rs. 15600-39100+AGP 6600 (**Revised 7<sup>th</sup> Pay Scale Level-13 Rs. 67300-206900**) in the Technical cadre, temporarily until further orders with effect from the date of their eligibility mentioned against their name.

Eligibility dates are shown against their name but no arrears will be paid to incumbent. The pay fixation from the date of eligibility will be imaginary till one day prior to date of issue of order. **Arrears order from date of eligible to 31.10.2022 will be issued separately.** The University will not use any budget given from M.P.
