The vishwa vidyalaya reserves the right to retain the partial or complete of funds, claims or any emoluments or complete or money belonging to second party as deemed fit in case of breach of condition No. 5 of the appointment order and non fulfillment of condition 3 mentioned above the second party shall be liable to face legal action as deemed fit at his cost and risk.

Any dispute arising between the parties in respect of any matter connected with his agreement shall be referred to the Vice-Chancellor, whose decision shall be final and binding.

3. The appointment is on the following terms and conditions:-

- (a) In case of a fresh appointment no T.D.A. will be paid for joining the post.
- (b) A fresh service book and leave account shall be opened in respect of those incumbents who are working as research associates in the Vishwa Vidyalaya. In their cases, the balance of leave should not be carried forward.
- (c) The incumbents shall earn annual increment only after completion of one year of service, as per rules.
- (d) The incumbents shall be required to submit a declaration in duplicate, alongwith their joining report that they are not registered for M. Phil. with any university, failing which their joining report should not be accepted. A copy of the declaration alongwith joining report may be forwarded to this office duly attested by the office-in-charge of the campus.

The appointment is temporary and can be terminated on one month's notice on either side or one month's salary in lieu thereof.

- (1) The candidate shall have to submit a medical certificate of physical fitness from the Vishwa Vidyalaya Medical Officer or Civil Surgeon of the district without which he shall not be allowed to draw his salary. In case he is not found physically fit, the appointment shall stand cancelled.
- (2) The candidate shall have to take an oath of allegiance to the Republic of India.
- (3) The antecedents of the candidate shall be got verified through the police and/or such other authorities as may be deemed fit and if anything derogatory is found about the character of the candidate in the report, his appointment shall be liable to be terminated at once without any notice.
- (4) The order shall stand cancelled if the candidate does not join duties within one month from the date of issue of this order.
- (5) The appointment shall be governed by all the existing rules and regulations of the Vishwa Vidyalaya and those to be framed/issued from time to time.
