ORDER

On the recommendation of the Selection Committee and approval of the Hon'ble Vice-Chancellor of the University; Ms. Alpana Kumhare D/O Shri Ram Kumar Kumhare is hereby appointed, temporarily, until further orders to the post of Assistant Professor (Agronomy) in the scale of pay of Rs. 15600-39100 (GP 6000) as per sixth pay commission (pre-revised) under Schedules Tribes category and posted at the KNK College of Horticulture, Mandsaur under following terms and conditions.

Terms and conditions:


1. The appointment shall be effective from the date of reporting of the duty on the post by the appointee (appointed candidate).
2. The appointment shall be on a probation for a period of two years from the date of joining and the period of probation shall be determined under the provisions laid down in the M.P. Fundamental Rules.
3. This appointment order is being issued in anticipation of the character verification of the appointee under the Memorandum No. F-C-15/2012/1/3, dated November 24, 2012, of the Government of Madhya Pradesh, General Administration Department, adopted by the University. 6. The appointee shall have to submit a medical certificate of physical fitness from the Chief Medical Officer or Civil Surgeon of the district of his/her appointment without which he/she shall not be allowed to draw first salary. In case he/ she is not found physically fit this appointment shall stand cancelled.
7. From the date of joining, the appointee will be abide by all the conditions of MP Civil Services (General Conditions of Service) Rules 1961 and all the orders issued or will be issued by the M. P. Government from time to time and adopted by the University.
8. The appointment is further on the following terms and conditions:
- (i) The order shall stand cancelled, if the appointee does not join the post within one month from the date of issue of this order.
 - (ii) The appointment is temporary. After completion of the Bond period, the services can be terminated on one month's notice on either side or one month's salary in lieu thereof.

TERMS AND CONDITIONS for the Selected Candidate:

1. The selected candidate must join duty within **15 days** from the date of issue of this order. Failure to do so will result in automatic cancellation of the engagement.
2. The selected candidate shall **not** be treated as a regular employee of the University and will be governed by the rules and regulations applicable to contractual engagements.
3. The engaged contractual teacher shall diligently perform all academic duties and other responsibilities assigned by the competent authorities. Compliance with such directions is mandatory and constitutes an essential part of the contractual obligations.
4. In the event of any refusal, non-compliance, or failure to perform assigned duties, the services of the contractual teacher shall be **terminated immediately**, without any further notice or entitlement to compensation.
5. The engaged teacher shall be paid a fixed honorarium of ₹42,000 (for candidates having Ph.D. or NET) or ₹35,000 (without NET or Ph.D. but having teaching experience of 03 years) per month, as applicable as per the V.V. notification क्र./कु.स./प्रशा./2024-25/3054 dated 01.01.2025. The Dean must verify the candidate's eligibility and supporting documents prior to processing the payment. No additional allowances such as HRA, CCA, or any other benefits shall be admissible.
6. **Payment of the fixed honorarium** will be subject to verification of attendance and submission of the monthly work report by the concerned Head of Department (HOD) / Head of Section (HS) / Dean. The remuneration shall be drawn from the **contingent head** of the respective college.
7. The engaged teacher **must not be on the regular pay roll** of any Government institution or institution aided by the Government of Madhya Pradesh or the Government of India.
8. The engaged contractual teacher shall be entitled to **one Casual Leave (CL) per month**. However, a maximum of **two CLs may be sanctioned** by the Dean in any

10. The **age limit** for engagement of contractual or retired teachers shall not exceed **70 years**.
11. The application of selected **contractual/retired teachers** shall **not be forwarded** by the Dean of the College or University authorities for any posts advertised by other institutions. However, an **experience certificate** in prescribed format of the university may be issued by the Dean upon request, if required by the candidate.
