

No. 507 dated 19.07.2008 and recognized by Govt. of India / Govt. of Madhya Pradesh (Name of the Agency) *vide* Act No. 4 of 2008 and recognized by University Grants Commission] at its Department of Agriculture/Horticulture and is involved in education, research and extension in the disciplines of Agriculture including Agronomy, Soil Science, Entomology, Pathology, Economics, Extension, Plant Breeding & Genetics, Horticulture related field and allied subjects (specific areas of research),

AND WHEREAS it has been considered expedient to agree in writing to participate jointly in the projects requiring expertise and logistics from both the parties.
