//ORDER//

On the recommendation of the Assessment Committee, constituted under the provisions of Section 5, 3 (B) (ii) of the R.V.S.K.V.V., Statute 2014 and approval of Hon'ble Vice Chancellor the following Programme Assistants presently working in T-4 grade (Category II) in the 6th Pay Scale of Rs. 9300-34800+AGP 4200 are upgraded/promoted to the level of T-5 grade in the pay scale of Rs. 9300-34800+AGP 4600 in the Technical cadre, temporarily until further orders with effect from the date of their eligibility mentioned against their name.
