

## Anti-ragging Report

Name of College: RAK College of Agriculture, Sehore M.P

The antiragging committee of RAK college of Agriculture, Sehore MP comprised Dr. SR. Ramgiry (Chairman) and members Dr. KN. Pathak, Dr. RP.Singh, Dr.M.Saxena, Dr.MD Vyas and Dr. RC. Jain. The committee received the ragging complaint from Dean college of Agriculture , Sehore on 23-12-2021 dated Acad/2021/1897.

The ragging committee carried out following activities against above ragging complaints and final report of above referred complaint no. ARCC/MP-6986 is being submitted as per JPEG format/point wise.

### 1. Detail of investigation Done by the anti-ragging committee members

1.The ragging committee issued the letters to students for their presence of before ragging committee on dated 24-12-2021 vide letters.Acad/2021/1904,1905,1906,1907,1940 ,1941,1942,1943.to present on 30-12-2021.

2. The antiragging meeting was held on 30-12-2021. But student did not face the committee.

3. The anti ragging committee meeting held and again called students to present before ragging committee on 07-01-2022 Perhaps Due to examination student did not appear and committee again call student to reappear on 17-01-2022 [Acad./2021/1999,2000,2001 letters

The committee interact with students to find out reasons/culprit of ragging and received the students statement viz.

1. Complaints lodged by namely Mr. Ankit Kanthiya, Mr. Sarvagya Shukla, Mr. Ayush Jain. as per below

2. Complaint against Mr. Sagar Singh khinchi, and Mr.Adarsh Kumar, Mr.Rahul Rajput.

3. Mr. Sarvagya Shukla Complainant sent a letter to inquiry committee on 29-12-2021 requesting that he is unable to present before anti-ragging committee due to some medical issues.

4. The anti ragging committee received email from anti ragging help line on 04-02-2022 through Dean CoA-Sehore of anti ragging Ref. No. ARCC./M.P 6986 and committee conducted meeting on 04-02-2022 for further investigation.

5. The ragging committee called students on 08-02-2022 on email for further investigation/video conferencing but student did not appear perhaps due to the running of practical examination.

6. The committee was always in close contact with the students for final investigation and conclusion regarding ragging report of students.

7. Students were called for further investigation on telephone on 16-3-22 but they did not appear before the ragging committee probably due to holy festival, hence committee further issued final letter mentioning that if they will not appear before the anti- ragging committee on 24-03-2022 positively, then only expert decision will be taken .

2. Conclusions of investigation:- After detail investigations and discussions amongst the committee members, it was found that the act was only hard discussion among the same class students (B.Sc Ag II year ).

The anti ragging committee recommended the punishment to students as "Debarring" from representing the insituation in any regional, national or international meet, tournament Youth festival etc. As per antiragging punishment 15.1e Academic regulations for under graduate degree programmes in Agriculture faculty (2019) RVSKVV Gwalior (M.P).

### 3. Details of punishment

1. The anti ragging committee meeting held on 30-12-21. 1.01.2022 and 17-01-22,08-02-22,16.03.22.and 24.03.22 and found as per below mention under point 2

2. Committee critically interacted with the students both complainers and culprit statement in written and physical discussions.Finally anti ragging committee found culprit namely Mr. Sagar Sing and Mr. Adarsh Kumar , Mr.Rahul rajput for punishment as per antiragging punishment rule 15.1e Academic regulations for under graduate degree programmes in Agriculutre faculty (2019) RVSKVV Gwalior, Madhya Pradesh the anti-ragging committee recommended that the punishment to the culprit students as under

**1 "Debarring" from representing the Institution in any regional, national or international meet, Tournament Youth festival etc.** This decision is taken by the committee with the view to maintain discipline and peace in the college and check such activities related to ragging so that smooth teaching and research activities could be carried out in the college premices.
