- 2. These posts are purely temporary and purely on contractual basis subject to satisfactory performance. The selected candidates shall have no right / claim for regular appointment or absorption in university at any point of time.
- 3. The appointment may be continued till requirement of the University and the appointment may be terminated at any time.
- Initially the appointment will be made for six months duration only and may be continued/ discontinued on the basis of performance of the candidate, However, maximum duration will not be extended beyond three years.
